


Typical characteristics of VSWR




Typical characteristics of VSWR




Typical characteristics of VSWR




Typical characteristics of radiation pattern (@1.575GHz)




Typical characteristics of radiation pattern (@2.45GHz)


Typical characteristics of VSWR(2GHz band)




Typical characteristics of VSWR(5GHz band)







Typical characteristics of VSWR




Typical characteristics of radiation pattern (@2.45GHz)











Typical characteristics of radiation pattern (@5.25GHz)
